Re: Board Action on OE Phone Contract Change from Nextiva to Vonage

Costs:

Current contract (Nextiva) \$154.71/month for 5 lines

Early termination up to \$1,500, actively negotiating lower terms

New contract (Vonage) \$182.21/month for 7 lines (\$240.38/month post-promo)

Includes 7 free phones.

Additional Phones \$800 for (3) specialty phones

**OE Input:** All Staff Reviewed and Endorse

**Summary:** The OE asks the Board to act on a contract exceeding one year in duration, which is beyond the Water Engineer's authority. The OE asks to cancel the existing OE contract with Nextiva, which began in May of 2022, moving to a new contact with Vonage. Administrative fees associated with transferring the FRWMB/OE phone number of (406)201-2532 from Nextiva to Vonage may apply.

# Alternatives Considered; Benefits Identified:

- No action is an option.
- Existing phones leave much to be desired poor speaker functions, routine malfunction needing reboot, lack of intuitive function, poor online service, and other dissatisfactory features.
- Eight other companies were considered with Vonage as a standout. Vonage personal service, ease of use, affordability, and service offerings seem like an excellent choice.

#### **Action Needed:**

Action Item #1: End current contract (Nextiva) and move to new contract (Vonage)

Action Item #2: Add two lines of service from five to seven

Action Item #3: Enter into either 24-month or 36-month new contract

Action Item #4: Purchase (3) specialty phones (Polycom E450) in addition to the (7)

phones included with the new contract (Polycom E220).
