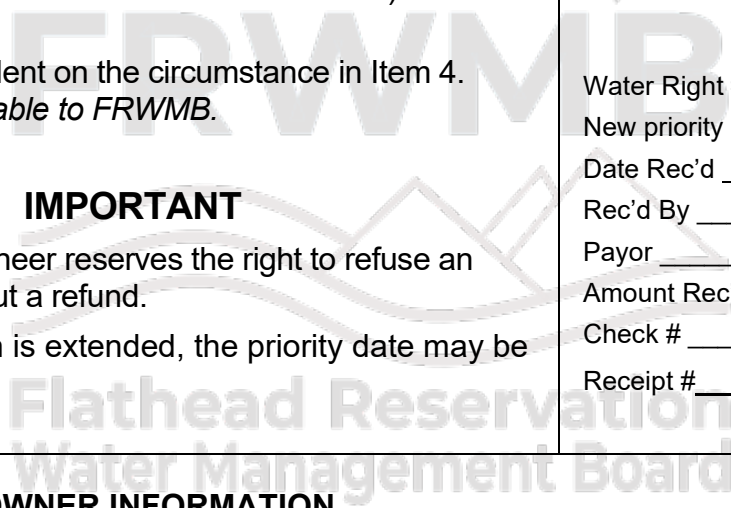

  - Must file before the original deadline.
  - If approved, this gives you a 6-month extension to your previous deadline.
  - The priority date of your water right may be adjusted.
- EXTEND MISSED DEADLINE FOR DOMESTIC OR STOCK ALLOWANCES OR GEOTHERMAL APPROPRIATIONS**
- **Filing fee of \$115 required.**
  - Must file within 6 months of the missed deadline.
  - If approved, this gives you a 6-month extension to your deadline.
  - The priority date of your water right may be adjusted.
- EXTEND RESPONSE TO A DEFECT LETTER OR AN APPLICATION TIMELINE**
- **Filing fee of \$65 required.**
  - Must file before the original deadline.
  - Length of extension is determined on a case-by-case basis.
  - The priority date of your water right may be adjusted.
- EXTEND MISSED FILING DEADLINE FOR REDUNDANT WELL OR SUBSTITUTE WELL NOTICES OF COMPLETION**
- **Filing fee of \$65 required.**
- EXTEND PROJECT COMPLETION DEADLINE FOR AN APPROPRIATION PERMIT OR CHANGE IN USE AUTHORIZATION**
- **Filing fee of \$400 required.**
  - Must file before the missed deadline.
  - Length of extension is determined by Water Engineer or Designee on a case-by-case basis.
  - The priority date of your prospective water right may be moved forward in time.
  - Attach documentation with the following:
    - Describe how many years you are requesting to complete your project.
    - Chronologically, describe what has been completed on this project?
    - Include photographs, receipts, contacts for design or construction, maps, or other information to show what work has been completed.
    - Describe how or if the information provided at issuance has changed? (Address cost, magnitude, engineering, physical features encountered in the project development, and timeline for completion of the project.)

5. **REMINDER**

You must file an Allowance Completion Notice (Part B) or a project completion notice (Ordinance 2-2-113) with the Office of the Engineer to receive a valid water right.

6. **EXTENSION APPLICANT DECLARATION**

I declare under penalty of perjury that the statements appearing here are, to the best of my knowledge, true and correct and affirm that I have possessory interest, or the written consent of the person with the possessory interest, in the point of diversion, place of use, and conveyance.
