Grammar/format errors to correct:

"programing" (misspelled multiple times) in these locations: §1.1.1, §1.1.2, §1.1.4, §2.1.1–§2.1.3

"Flathead Water Management Board" is used throughout the document and should be replaced with Flathead Reservation Water Management Board and then (FRWMB) Other grammatical edits include:

"Sept 30,2025" §1.1.6 Add space: "Sept 30, 2025"

"and and" Project Narrative, Phase 1 Change to just "and"

To strengthen the contract and protect FRWMB's interest:

1. Add Site Location Statement:

"The final facility site shall be located within the boundaries of the Flathead Indian Reservation, and selected in consultation with CSKT planning staff."

2. Acknowledge Tribal & State Funding Requirements:

"The Architect shall assist the Owner in preparing materials required to satisfy both State of Montana and CSKT capital funding requirements."

3. Add Coordination with Tribal Authorities:

"Architect shall coordinate with CSKT Tribal authorities as needed to ensure project compliance with Tribal land-use planning and environmental standards."

4. Clarify "Additional Services":

We may wish to revise Section 5.3 or include a definition list in Article 6:

"Supplemental and Additional Services may include—but are not limited to—revisions beyond the agreed program, additional site visits, extra renderings, or attendance at unplanned public or Tribal council meetings."
